WELDING

Please note that, for SAFETY reasons, no welding may be carried out by anyone (including boat owners) other than by Peake Yacht Services approved welding contractors. For a list of approved welding contractors, please apply to the FRONT Office between the hours of 8.00am and 4.00pm, Monday to Friday.

A Gas Free Certificate must be obtained before any hot work is to be undertaken. A certificate must be obtained daily, as each certificate is only valid for 1 (one) day.

LAUNCH BOOKINGS

The Customer Service Office requires four (4) working days' notice for bookings to launch. Boats will not be launched until all bills are settled in full. Boats may only stay in the travelift slip at the discretion of the travelift operator and there will be a charge made for this (see above).
